ROTISSERIE ACCESSORY SET




ROLLING CAGE

USE

- Place food such as french fries inside the rolling cage and close.
- For assembly, use the rotisserie rod and place through the rolling cage (1& 2). Then insert food into rolling cage (3) and close (4). Place inside the unit (5). The rolling cage fits inside of the unit by placing one end in first then the other on the groves inside the unit. Remove using the rotisserie handle (6).

• Hand washing is recommended.






SKEWER RACK

USE

- · Place food on skewers.
- For assembly, use the rotisserie rod, place through the center of the skewer rack attaching one end at a time then assemble other end on the rod(1-4)). Then insert food on the skewers(5). To place the skewers on the rack, put one skewer per groove (6) on the rack. The skewers will lock in place (7-8). Once all skewers are on the rack, place inside the unit (9). The skewer rack fits inside of the unit by placing one end in first then the other on the groves inside the unit. Remove using the rotisserie handle.


GRILL CAGE

USE

Place food inside for grilling such as chicken or steak. The grill cage fits inside of the unit by
placing one end in first then the other on the groves inside the unit. Remove using the
rotisserie handle.
