Prior to use, the user must read the following instructions carefully and pay special attention to the safety & precautions to ensure proper product operation. Keep this user manual for further reference.

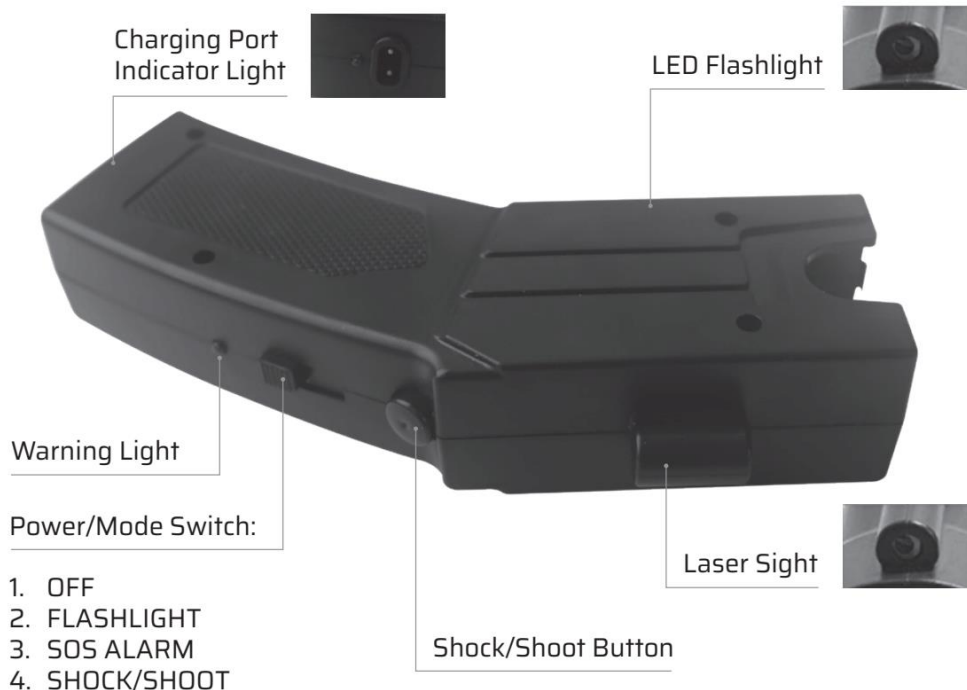
WARNING

⚠ To avoid accidental discharge, always move the on/off switch to the “off” position when not in use. The user must abide by all local laws governing the possession and use of stun guns. Do NOT expose your eyes to the LED light. Keep away from children under the age of eighteen (18).

INSTRUCTIONS FOR USE

The Power/Mode Switch has four Operating Settings:

1. The device is Powered Off and can be safely stored away without any risk of accidental discharge.
2. Activates the LED Flashlight.
3. Activates the SOS Alarm.
4. Activates the stun gun for use (Shock/Shoot). The warning light located on the handle will automatically illuminate red, letting you know that the device is ready to Shock/Shoot. Press the Activate Shock/Shoot button to deploy the electrified cartridge (3 provided).

USING THE STUN GUN

Close Contact:

Set the switch to the Shock/Shoot position and put the tip of the stun gun directly in contact with the assailant. Press the Shock/Shoot button to activate. Please note, while holding the stun gun against the body, you will not see or hear the spark. You can continue to fire the stun gun for as long as necessary without damaging the device.

The most effective stun areas: shoulders, hips, thigh, buttocks, and below the ribcage.

From a Distance:

Install the cartridge on the tip of the stun gun. Once locked in place, press the Shock/ Shoot Button. The cartridge will automatically deploy 2 steel needles and administer the electric shock.

Note: The steel needles remain connected to the stun gun with wires, allowing the user to remain at an effective and safe distance of 10-15 Feet (3-5 meters).

Each electric shock lasts for 2-3 seconds.

Effects of the Stun Gun

- A shock from the stun gun lasting one second or less will cause pain and minor muscle contractions.
- Stunning the assailant for 1 to 2 full seconds will cause muscle spasms and a dazed mental state.
- Stunning the assailant for 3 to 5 full seconds will result in loss of balance and muscle control.
- DANGER: Long-term electric shock causes damage to the human body.

CHARGING INSTRUCTIONS

To recharge, insert the provided cord to the charging port located on the bottom of the handle of the device. Extend the cord and insert the AC plug end into a standard 110v/220v AC wall socket. Charge time is approximately 5 hours.

WARRANTY

1-Year Limited Manufacturer's Warranty

Your SafetyVital product is backed by a one-year limited manufacturer's warranty. For a period of one year following date of purchase, SafetyVital will repair or replace your device should it fail due to a manufacturer's defect (subject to certain limitations such as, but not limited to, use of the device as directed or performing the intended function during which the product may become damaged).

This one-year limited warranty does not cover any damage that results from unauthorized or improper use, service, or repair. Further, it does not cover damage caused by accident, intended function and use as directed, negligence, or normal wear and tear.
